We do not supply any shade structures or tie downs for your shade structure, please plan accordingly.

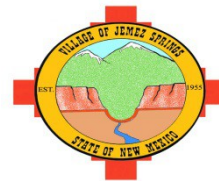
You are responsible for your items and belongings.

Hold Harmless and Indemnity Agreement

- The Profit/ Non-Profit/ Family / Private organization shall hold harmless and indemnify the Village of Jemez Springs, its officers, employees, agents and attorneys from all claims, liabilities, obligations, losses and the like, asserted by any third parties arising from or caused by the organizations negligence, misrepresentation, fraud, malpractice or any other occurrences in and around their assigned area. This indemnity and hold harmless agreement shall include reimbursement of all attorney fees, costs and expenses incurred by the Village of Jemez Springs, its officers, employees, agents and attorneys in defending any such action.

Safety Requirements

- All booths, games, bandstands, etc. must be set up in a manner in which Emergency Vehicles can access both South & North Entrances. At NO time will access to the Jemez River be blocked unless permission is obtained from the Jemez Springs Fire Chief.
